### General Description

On October 6, 2020 the Georgia Public Service Commission (PSC) in Docket No. 43466, approved an all-services distributed overlay as the relief method for the 404/470/678/770 NPA. The 404/470/678/770 NPA currently serves the metropolitan area of the City of Atlanta including but not limited to Alpharetta, Duluth, Dunwoody, East Point, Forest Park, Gainesville, Griffin, Lawrenceville, Mableton, Marietta, Peachtree City, Roswell, Sandy Springs, Smyrna and Tucker. The new 943 NPA will serve the same geographic area currently served by the existing 404/470/678/770 NPA. Additionally, the order specifies that central office codes in the 943 NPA will be available for assignment only when all assignable prefixes in the 404/470/678/770 area codes have all been exhausted.

### Implementation of Relief Plan

Implementation of the 404/470/678/770/943 NPA overlay is as follows:

## Network Testing

All international and domestic carriers should ensure that the new 943 NPA has been activated throughout their networks prior to August 15, 2022. The test number to verify the routing to the 943 NPA will be in service beginning May 15, 2022 through September 15, 2022. The test number to verify the routing to the 943 NPA is: 943-943-1943. A recorded announcement will indicate the test call has been successfully completed.
