 Subject: NPA 424 to Overlay NPA 310 (California)
 Related Previous Planning Letters: 125, 250

General Description

On August 25, 2005 the California Public Utilities Commission (CPUC) in Order D.05-08-040 approved an all-services distributed overlay as the relief method for the 310 NPA. The 310 NPA serves the western portion of Los Angeles County in Southern California, including cities and communities such as Avalon, Beverly Hills, Carson, Culver City, Compton, El Segundo, Gardena, Hawthorne, Hermosa Beach, Inglewood, Lawndale, Lomita, Lynwood, Malibu, Manhattan Beach, Palos Verdes Estates, Rancho Palos Verdes, Redondo Beach, Rolling Hills, Rolling Hills Estates, Santa Monica, Torrance, portions of Los Angeles, the LAX airport and small portions of Long Beach and West Hollywood. This planning letter replaces PL-125 and PL-250.

The new **424 NPA** will serve the same geographic area currently served by the existing 310 NPA.

Implementation of Relief Plan

Implementation of the overlay of the 424 NPA is as follows:

During the permissive dialing period, subscribers may dial calls within the overlay area on either a 7-digit or 1+10-digit basis, but will be encouraged to dial 1+10-digits. After the permissive period ends, all calls must be dialed using 1+10-digits.

Central Office Code Listings and NPA Map

A map of the 310/424 NPA overlay is attached. An updated list of NXX codes assigned to the affected area may be found in the Local Exchange Routing Guide (LERG) or the NPA NXX Activity Guide (NNAG). Information in the LERG and NNAG can be obtained by contacting Telcordia Routing Administration (TRA), at 732-699-6700.

Dialing Plan

Coincident with the introduction of mandatory 1+10-digit dialing on July 26, 2006, the dialing plan for the 310 and 424 NPAs will be as follows:

Type of call	Call terminating in	Dialing plan
Local call	Home NPA (HNPA) or Foreign NPA (FNPA)	1 + 10-digits (1 + NPA-NXX-XXXX)
Toll call	HNPA or FNPA	1 + 10-digits (1 + NPA-NXX-XXXX)
Operator Services Credit card, collect, third party	HNPA or FNPA	0 + 10-digits (0 + NPA-NXX-XXXX)

Network Testing

All international and domestic carriers should ensure that the new 424 NPA has been activated throughout their networks prior to August 26, 2006. A test number to verify the routing to the new NPA will be in service beginning November 30, 2005 through September 26, 2006. The test number to verify the routing to the 424 NPA is 424-424-0424. A recorded announcement will indicate that the test call has been successfully completed.

General Information

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions. The implementation of the plan described in this letter is the responsibility of individual service providers, and NANPA does not guarantee that the activities and plans will occur exactly as described herein.

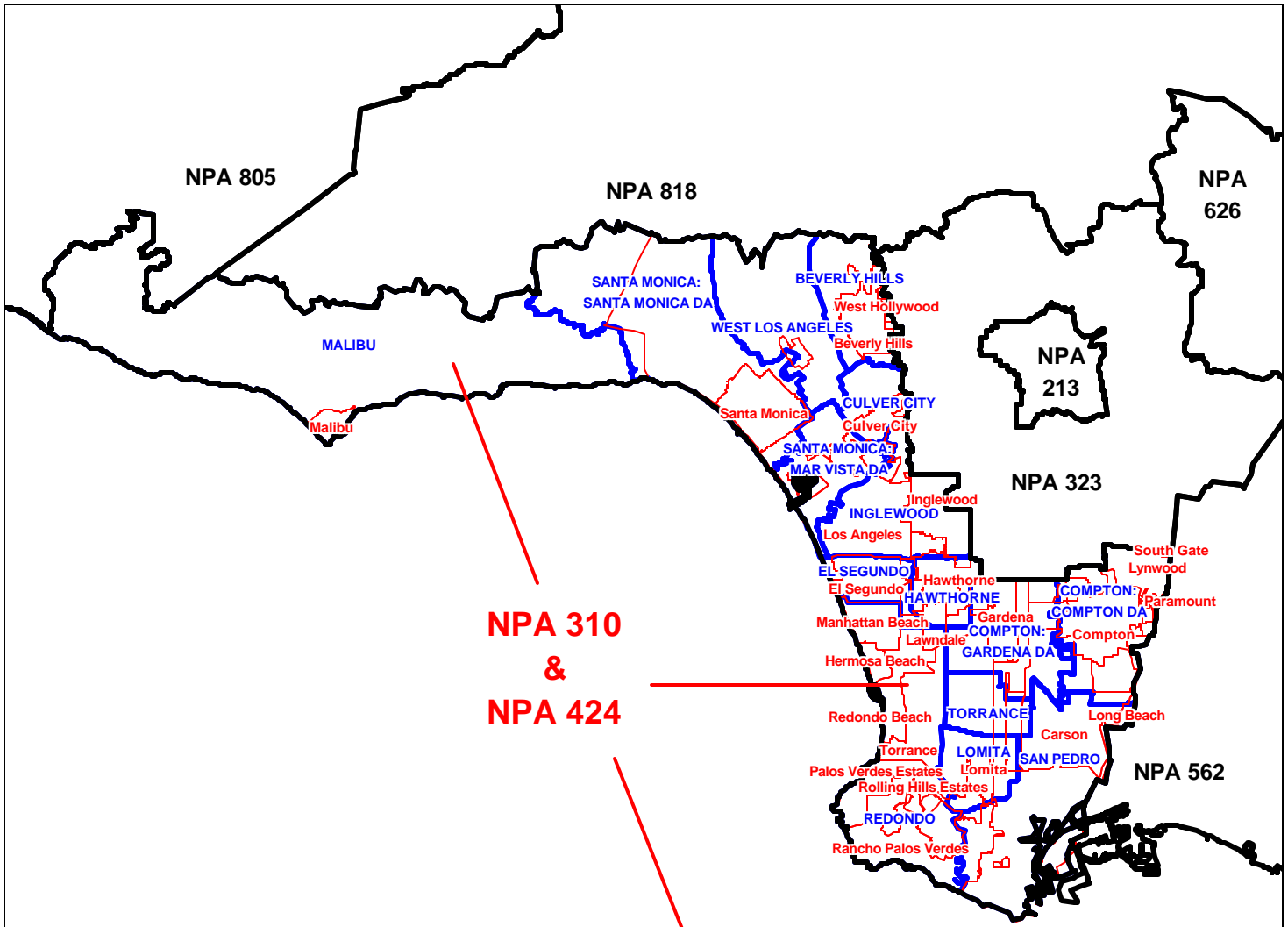
