 Subject: Expansion of the Concentrated NPA 971 Overlay with NPA 503 (Oregon)
 Related Previous Planning Letters: PL-182

General Description

On November 21, 2006 the Oregon Public Utility Commission, (OPUC) approved the Industry plan for the expansion of the 503-971 NPA concentrated overlay for the remaining 14 rate centers in the coastal counties of Clatsop and Tillamook. The coastal rate areas are: Astoria, Bay City, Beaver, Cannon Beach, Cloverdale, Garibaldi, Jewell, Knappa, Nehalem, Pacific City, Rockaway Beach, Seaside, Tillamook and Warrenton. Some of the communities served in these rate centers include: Astoria, Bay City, Beaver, Cannon Beach, Cloverdale, Garibaldi, Jewell, Knappa, Nehalem, Pacific City, Rockaway, Seaside, Tillamook and Warrenton.

Implementation of Overlay Expansion

In preparation for the expansion of the overlay code and mandatory 10 digit dialing, a permissive dialing period will begin on October 21, 2007, during which subscribers in the geographic area served by the overlay, will be encouraged to dial 10 digits (i.e. NPA + NXX + XXXX) for all local, extended area service calls within the overlay area. Beginning on April 27, 2008, at 12:01 a.m. (PT) all local and extended area service calls within and between the 503 and 971 NPAs in the overlay area will require 10-digit dialing. After the beginning of mandatory 10-digit dialing on April 27, 2008, the dialing plan for the 503 coastal area and the 503/971 overlay area will be as follows:

Implementation of the overlay expansion of the 971 NPA is as follows:

During the permissive dialing period, subscribers in the coastal area may dial local calls within the overlay area on either a 7-digit or 10-digit basis, but will be encouraged to dial 10-digits. After the permissive period ends, all calls must be dialed using 10-digits.

When preparing for overlay area code relief, carriers are strongly encouraged to prepare their switches to begin sending 10 digits prior to the mandatory 10-digit dialing conversion date for customers.

Dialing Plan

Coincident with the introduction of mandatory 10-digit dialing, the dialing plan for the 503 and 971 NPAs will be as follows:

| Type of call | Call terminating in | Dialing plan |

| Operator Services Credit card, collect, third party | HNPA or FNPA | 0 + 10-digits (0 + NPA-NXX-XXXX) |

Network Testing

All international and domestic carriers should ensure that the 971 NPA has been activated throughout their networks. The industry has decided that a test number is not necessary for the expansion of the overlay.

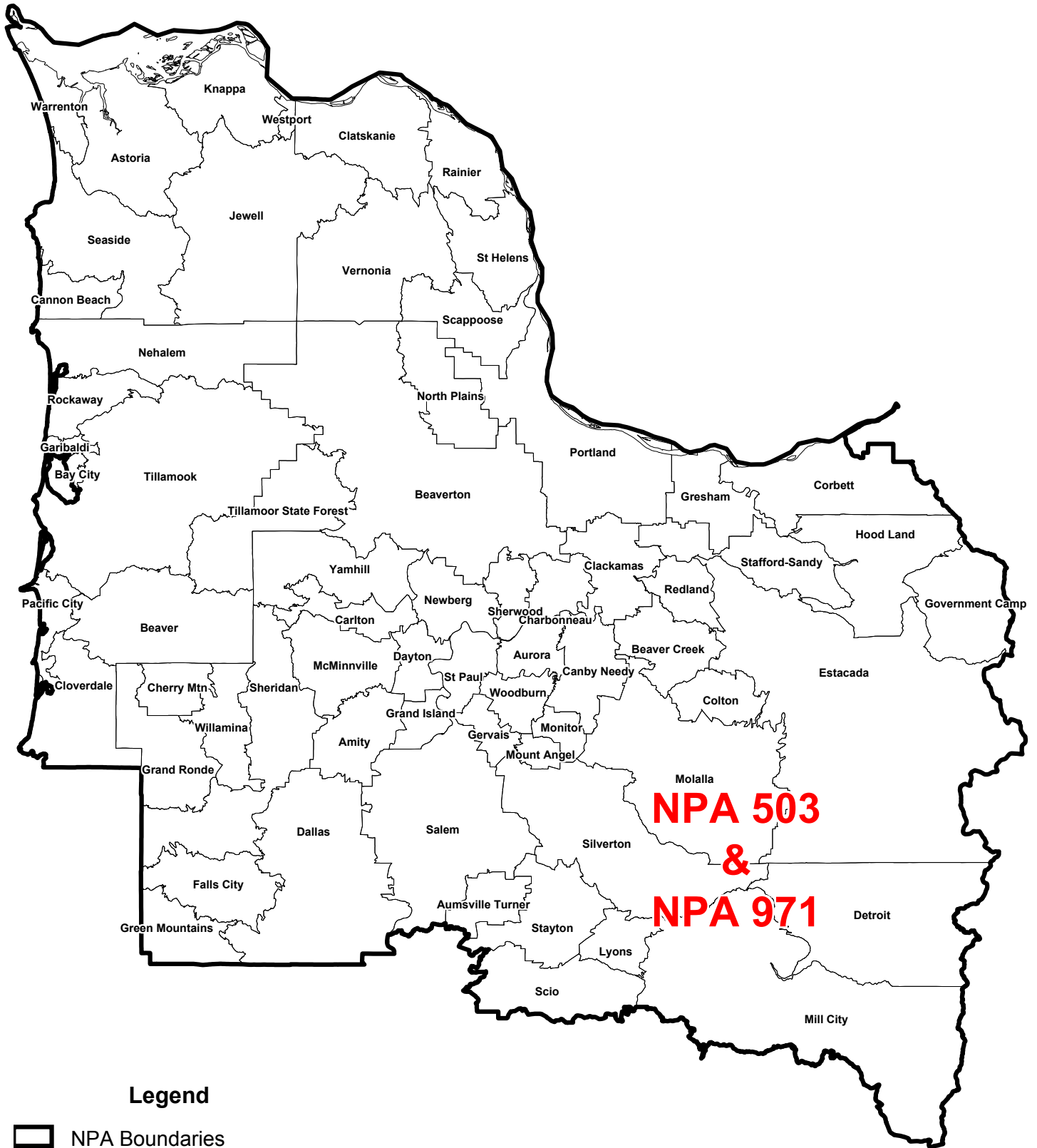
