### General Description

On March 21, 2007 the Louisiana Public Service Commission (LPSC) in Special Order No. 10-2007 approved a Rate Center Consolidation (RCC) Plan for the 504/985 NPAs as follows: The Delacroix, Lake Catherine, St. Bernard and Yscloskey rate centers in the 504 area code will be transitioned to the New Orleans rate center. The Buras, Pointe-a-la-Hache and Port Sulphur rate centers in the 985 area code will also be consolidated into the New Orleans rate center as part of a NPA Boundary Realignment. The Venice rate center in the 985 area code will remain an independent rate center but will be moved to the 504 area code as part of the Boundary Realignment. ### Implementation of RCC and Boundary Realignment Plan

Implementation of the 504/985 NPAs RCC and Boundary Realignment plan is as follows:

Start of permissive dialing	12:01 AM Central	July 29, 2007
End of permissive dialing	11:59 PM Central	April 30, 2008
Start of mandatory dialing	12:00 AM Central	May 1, 2008

During the permissive dialing period, calls to end customers located in the Buras, Pointe-a-la-Hache, Port Sulphur and Venice rate centers will be completed using either a 985 or a 504 telephone number. After the permissive period ends, all calls must be dialed using the 504 area code.

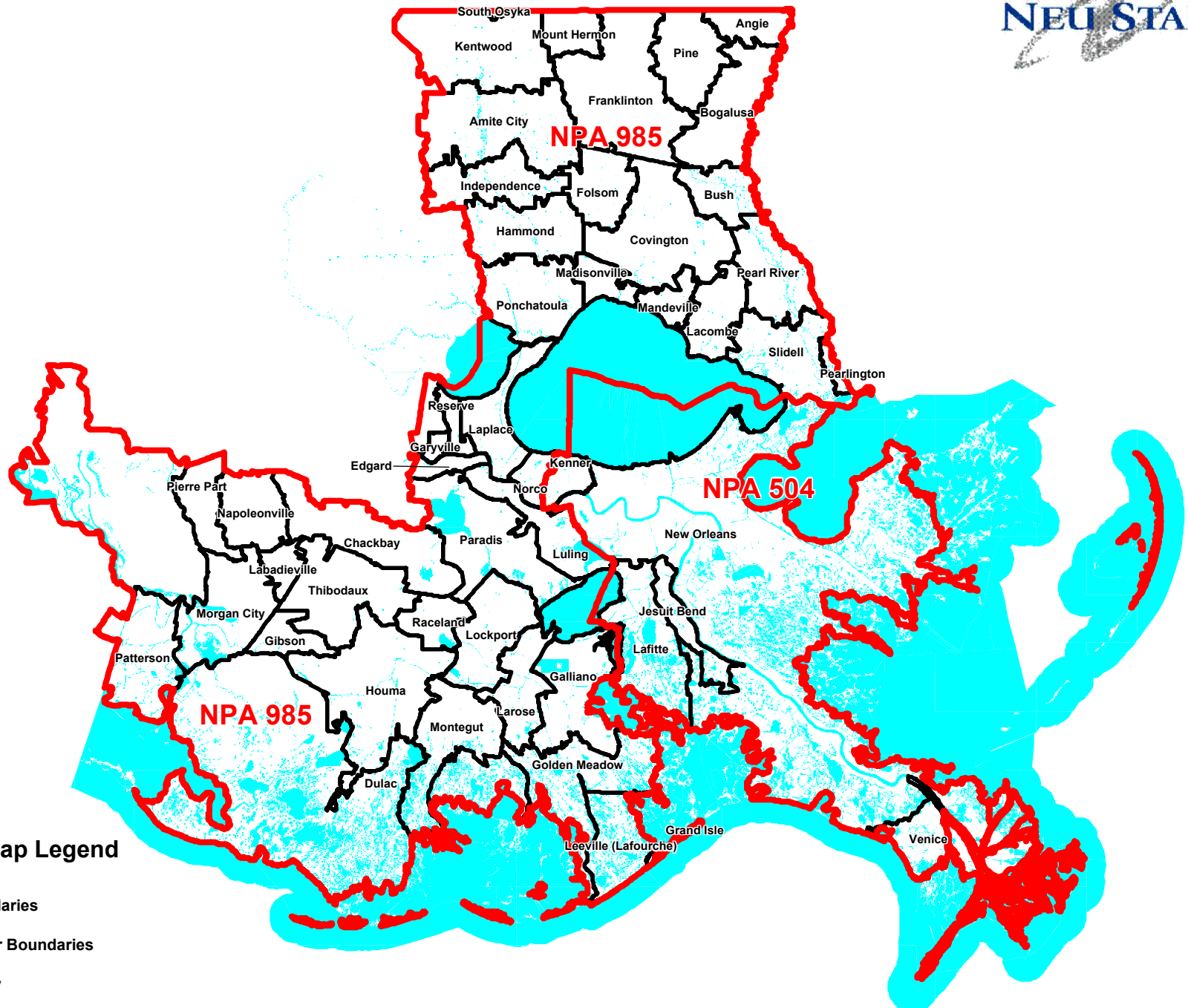
