### General Description

On April 24, 2008 the California Public Utilities Commission (CPUC) in Order D.08-04-059 approved an all-services overlay as the relief method for the 818 NPA. The 818 NPA generally covers most of the San Fernando Valley portion of Los Angeles County and a small portion of Ventura County and principally serves the communities of Agoura Hills, Burbank, Canoga Park, Calabasas, Glendale, Granada Hills, Hidden Hills, La Canada Flintridge, La Crecenta, Los Angeles, North Hollywood, Northridge, Oak Park, Pasadena, Pacoima, Reseda, San Fernando, Sepulveda, Sun Valley, Sunland Tujunga, Thousand Oaks, Van Nuys and Westlake Village. The new **747 NPA** will serve the same geographic area currently served by the existing 818 NPA.

### Implementation of Relief Plan

Implementation of the overlay of the 747 NPA is as follows:

During the permissive dialing period, subscribers may dial calls within the overlay area on either a 7-digit or 1+10-digit basis, but will be encouraged to dial 1+10-digits. After the permissive period ends, all calls must be dialed using 1+10-digits.

## Dialing Plan

Coincident with the introduction of mandatory 1+10-digit dialing on April 18, 2009, the dialing plan for the 818 and 747 NPAs will be as follows:

Local call	Home NPA (HNPA) or Foreign NPA (FNPA)	1 + 10-digits (1 + NPA-NXX-XXXX)
Toll call	HNPA or FNPA	1 + 10-digits (1 + NPA-NXX-XXXX)
Operator Services Credit card, collect, third party	HNPA or FNPA	0 + 10-digits (0 + NPA-NXX-XXXX)

## Network Testing

All international and domestic carriers should ensure that the new 747 NPA has been activated throughout their networks prior to May 18, 2009. A test number to verify the routing to the new NPA will be in service beginning February 18, 2009 through August 18, 2009. The test number to verify the routing to the 747 NPA is (747) 222-8378 (TEST). A recorded announcement will indicate that the test call has been successfully completed.

## General Information

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions. The implementation of the plan described in this letter is the responsibility of individual service providers, and NANPA does not guarantee that the activities and plans will occur exactly as described herein.

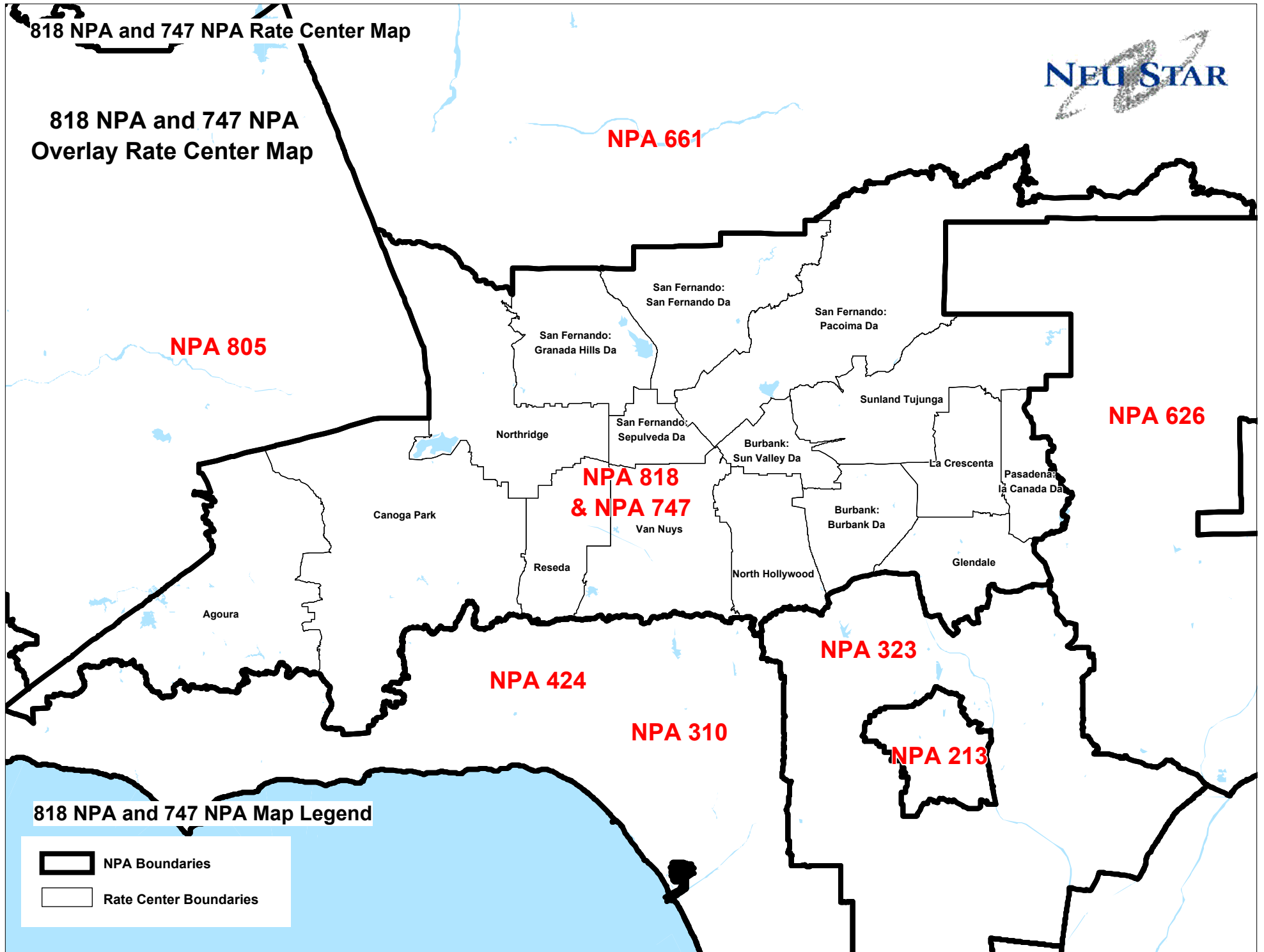
