Subject: Introduction of NPA 721 (Sint Maarten, Netherlands Antilles)

### General Description

The Government of St. Maarten, NA has requested, and has been granted, permission to enter the NANP. On September 30, 2009, NANPA assigned the 721 NPA to serve St. Maarten. Previously, St. Maarten was under Country Code 599.

### Implementation of the New 721 NPA

Introduction of the 721 NPA will begin with a period of permissive dialing. During the permissive dialing period, the use of either the current country code of 599 or the new 721 NPA will be acceptable for a dialed number terminating in St. Maarten. After the permissive dialing period ends, all calls dialed with the incorrect country code will be routed to intercept and a recorded message instructing callers to dial the correct country (1) and area code (721). Country code 599 will continue to be used in the remainder of the Netherlands Antilles.

Key implementation dates are as follows:

Since this information may change over time, please consult the Local Exchange Routing Guide (LERG) or the NXX Activity Guide (NNAG) for updated information. Detailed information for

the 721 NPA will be available in time for inclusion in the LERG at least 6 months before the start of permissive dialing. Information in the LERG and NNAG is available by license contract from Telcordia Routing Administration (TRA), at 732-699-6700.

The dialing procedures during and after the permissive period for the 721 NPA will be as follows:

## Network Testing

All international and domestic carriers should ensure that the 721 NPA has been activated throughout their networks prior to May 31, 2010. A test number to verify the routing to the new NPA will be announced at a later date.
