General Description

On December 16, 2009 the State of New York Public Service Commission in its order of Case 09-C-0058, approved an all services overlay as the relief method for the 718/347 NPA. The 718/347 NPA covers the Brooklyn, Queens, Bronx and Staten Island area of New York. The new 929 **NPA** will serve the same geographic area currently served by the existing 718/347 NPA.

Implementation of Relief Plan

Implementation of the overlay of the 929 NPA is as follows:

Network Testing

All international and domestic carriers should ensure that the 929 NPA has been activated throughout their networks prior to April 16, 2011. The test number to verify the routing to the new NPA will be in service beginning December 14, 2010 through July 11, 2011. The test number to verify the routing to the 929 NPA is: 929-222-9901. A recorded announcement will indicate that the test call has been successfully completed.
