Subject: NPA 365 to Overlay NPA 289/905 (Southern Ontario, Canada)
Related Previous Planning Letters: PL-420

This Planning Letter changes the Exchange Area for both NPA 365-610 Test Numbers from Hamilton to South Pickering.

In Telecom Decision CRTC 2010-213 dated 13 April 2010, the Canadian Radio-television and Telecommunications Commission (CRTC) directed that relief for Ontario area codes 289/905 be provided through a distributed overlay of a new area code 365 starting 25 March 2013.

New area code 365 has been assigned by the North American Numbering Plan Administrator and will be implemented on the Relief Date of 25 March 2013 as a distributed overlay over the geographic area of southern Ontario currently served by the 289 and 905 area codes. The area served by NPA codes 289/905 and the new 365 NPA code includes the major communities of Ajax-Pickering, Brampton, Burlington, Hamilton, Markham, Milton, Mississauga, Oakville, Oshawa, Richmond Hill, St. Catharines, and Whitby. A map showing the location of the area served by NPAs 289 and 905, and a list of the 94 Exchange Areas in the area are attached to this letter.

When the new 365 NPA is introduced, no changes will take place in the dialling plans in the area that is served by NPAs 289/905 and will be served by NPA 365. The dialling plan in this area will continue to be:

- all local calls including Extended Area Service calls will be dialled with 10 digits
- toll and alternatively billed calls will be dialled with 10 digits after the appropriate prefix digit(s)

All international and domestic Telecommunications Service Providers (TSPs) should activate the new 365 NPA throughout their networks by the start date for network testing (7 January 2013).

The following test numbers for the new NPA 365 will be made available effective 7 January 2013. Routing of calls to NPA 365 can be verified by dialling the 8378 (TEST) numbers which do not provide answer supervision. Billing of calls to NPA 365 can be verified by dialling the 2455 (BILL) numbers which provide answer supervision.

"You have successfully completed a call to the 365 area code test number at [CARRIER NAME] in Ontario, Canada."

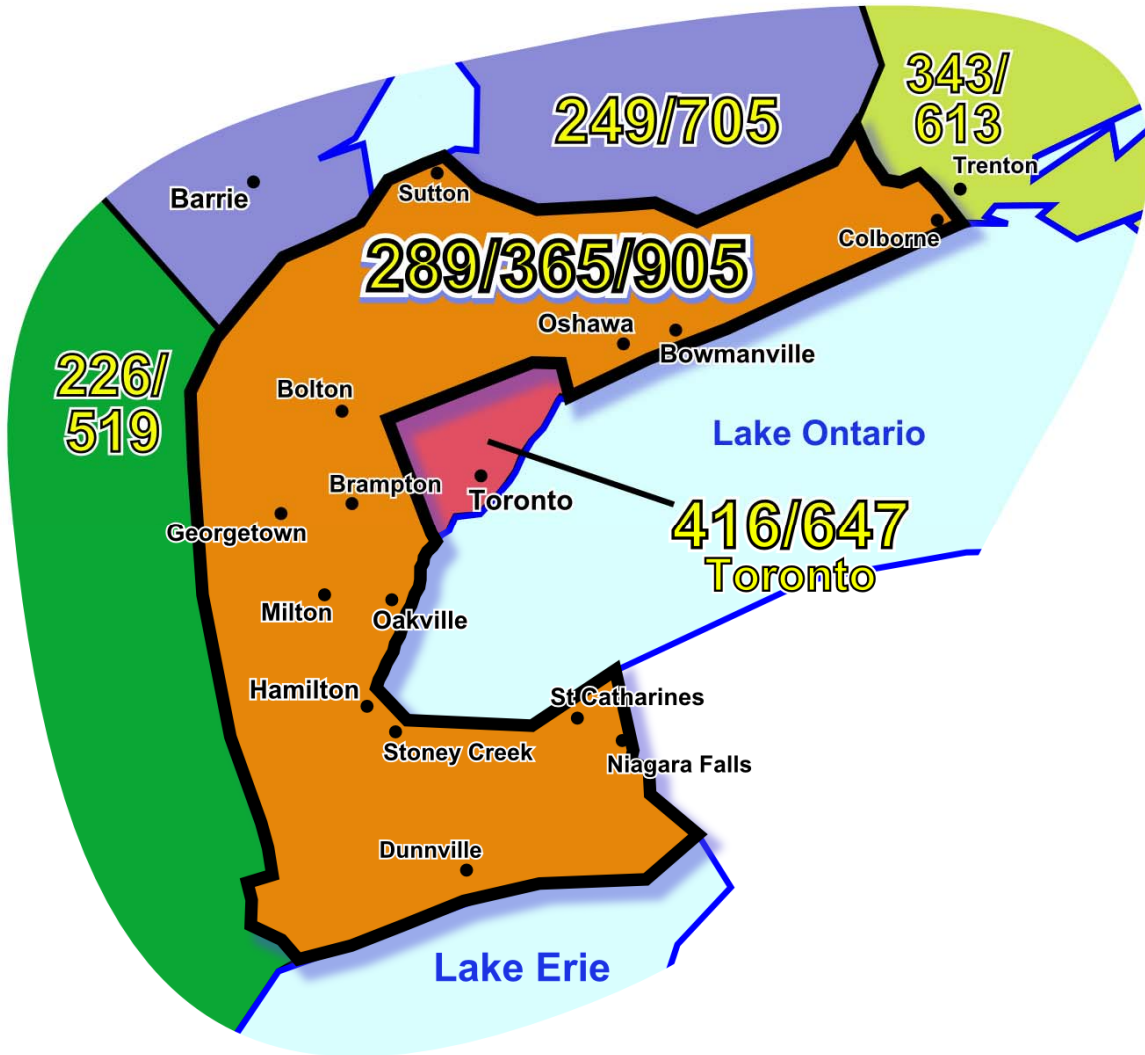
The disconnection dates for the test numbers will be between 25 April 2013 and 25 May 2013.

Central Office (NXX) Codes within NPA 365 may be assigned to TSPs starting from 25 September 2012, but cannot be activated in the PSTN prior to the Relief Date of 25 March 2013.
