General Description

On July 16, 2015, the State of New York Public Service Commission in its order of Case Number: 07-C-1486, approved an all services overlay as the relief method for the 315 NPA. The 315 NPA covers the west-central portion of New York serving communities such as Syracuse, Utica and Watertown. The new **680 NPA** will serve the same geographic area currently served by the existing 315 NPA. A map showing the area served by these NPAs is attached.

Implementation of Relief Plan

Implementation of the overlay of the 680 NPA is as follows:

Earliest date central office codes in the new NPA may be ordered through NANPA	-	January 4, 2017

During the permissive dialing period, subscribers may dial local calls within the overlay area on either a 7-digit or 10-digit basis, but will be encouraged to dial 10-digits. After the permissive period ends, all calls must be dialed using 10-digits.

When preparing for overlay area code relief, carriers are strongly encouraged to prepare their switches to begin sending 10 digits prior to the mandatory 10-digit dialing conversion date for customers.

Dialing Plan

Coincident with the introduction of mandatory 10-digit dialing, the dialing plan for the 315 and 680 NPAs will be as follows:

Type of call	Call terminating in	Dialing plan
Local & Toll Calls	Overlay NPAs (Within and between 315 and 680)	10-digits (NPA-NXX-XXXX)*
Local & Toll calls	Foreign NPA (FNPA) outside of overlay NPAs	1 + 10-digits (1 + NPA-NXX-XXXX)
Operator Services Credit card, collect, third party	HNPA or FNPA	0 + 10-digits (0 + NPA-NXX-XXXX)

*1+10-digit dialing for all calls permissible at service provider's discretion

Network Testing

All international and domestic carriers should ensure that the new 680 NPA has been activated throughout their networks prior to March 11, 2017 (Effective date of new NPA). The test number to verify the routing to the new NPA will be in service beginning November 11, 2016 through April 11, 2017. The test number to verify the routing to the 680 NPA is 680-990-8378 (TEST). A recorded announcement will indicate that the test call has been successfully completed.

General Information

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions. The implementation of the plan described in this letter is the responsibility of individual service providers, and NANPA does not guarantee that the activities and plans will occur exactly as described herein.

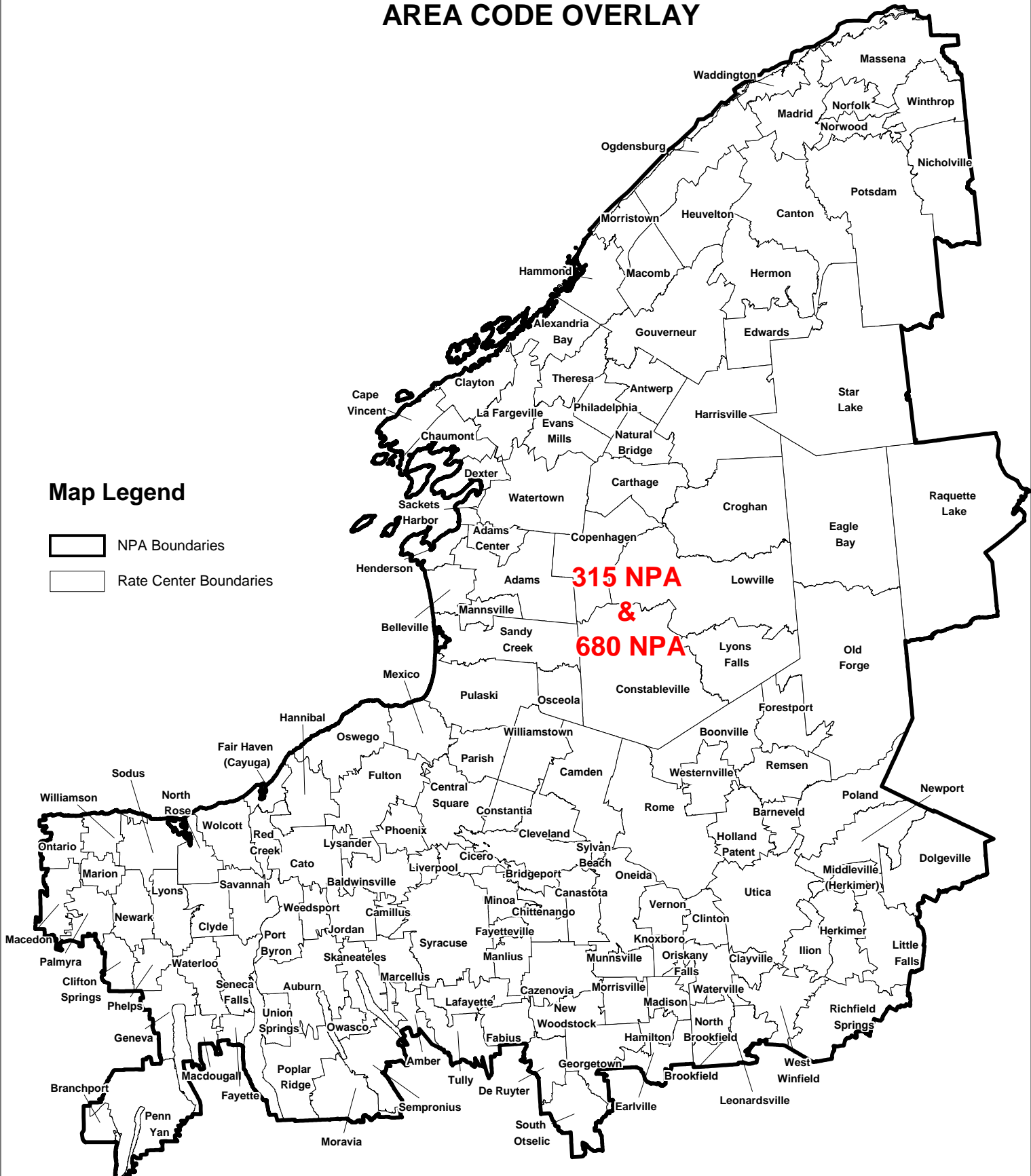
