### General Description

On November 19, 2015 the State of New York Public Service Commission in its order of Case 15-C-0168, approved an all services overlay as the relief method for the 212/646/917 NPA. The 212/646/917 NPA serves the Manhattan area of New York City. The new **332 NPA** will serve the rate center New York City Zone 01 which is the same geographic area currently served by the existing 212/646/917 NPA.

### Implementation of Relief Plan

Implementation of the overlay of the 332 NPA is as follows:

## Network Testing

All international and domestic carriers should ensure that the 332 NPA has been activated throughout their networks prior to June 10, 2017. The test number to verify the routing to the new NPA will be in service beginning March 10, 2017 through July 10, 2017. The test number to verify the routing to the 332 NPA is: 332-990-8378 (TEST). A recorded announcement will indicate that the test call has been successfully completed.
