Abstract

This IL provides industry notification of the impending split of the 703 NPA.

Letter Information (Includes safety liability disclaimer (if applicable), ordering information, originator's signature information)

We have been advised by Bell Atlantic that substantial telephone number growth in the Washington D.C. metropolitan area of Virginia necessitates splitting the existing 703 NPA and the simultaneous introduction of a new 540 NPA.

Excluding the Stafford Rate Center, the Washington D.C. metropolitan LATA portion of 703 will retain the 703 area code and will continue to serve Arlington County, the cities of Alexandria, Fairfax, Falls Church, Manassas, and the towns of Herndon, Quantico, and Vienna. The 703 area code will also continue to serve the Leesburg Rate Center which includes the town of Leesburg. The remainder of the current 703 NPA will be transferred to the new 540 area code.

The split of the 703 NPA is scheduled for 2:00 AM Eastern Daylight Time, Saturday, July 15, 1995. The permissive dialing period will begin at 2:00 AM Eastern Daylight Time, Saturday, July 15, 1995, and end at 2:00 AM Eastern Daylight Time, Saturday, July 13, 1996. During the permissive dialing period either 703 or 540 will be acceptable in a dialed number terminating in the new 540 NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept. Changes in the local exchange routing information, based on data provided by Bell Atlantic, will be incorporated into the LERG and the NPA NXX Activity Guide (NNAG) and will be available December 1, 1994.

Central Offices in the area to be served by the 540 NPA will be modified on a progressive basis to transmit "540" in the calling number Automatic Number Identification (ANI) between August 1, 1995 and February 16, 1996. Bell Atlantic will convert all pertinent records to 540 the weekend of February 16 - 19, 1996. This includes customer service records and associated NPA information in other systems. After February 19, 1996, all inquiries must refer to the correct NPA code.

Test calls to verify routing to the new NPA can be made by calling 540-829-9910. This test number will become available on June 15, 1995, and remain operational until August 13, 1996. A recorded announcement will indicate that the test call has been successfully completed.

The attached map illustrates the 703 and 540 configuration after the split. A listing of the rate centers to be served by each area code is also included.

The dialing plan for the new 540 NPA will be as follows:

- All Home NPA (HNPA) and Foreign NPA (FNPA) direct dialed local calls will be dialed on a 7 digit basis with no prefix, i.e., NXX + XXXX (7 digits).
- All HNPA direct dialed toll calls will be dialed with a prefix "1" and 10 digits, i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).
- All FNPA direct dialed toll calls will be dialed with a prefix "1" and 10 digits, i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- All operator assisted calls including credit card, collect, and third party calls will be dialed with a "0" prefix and 10 digits, i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).

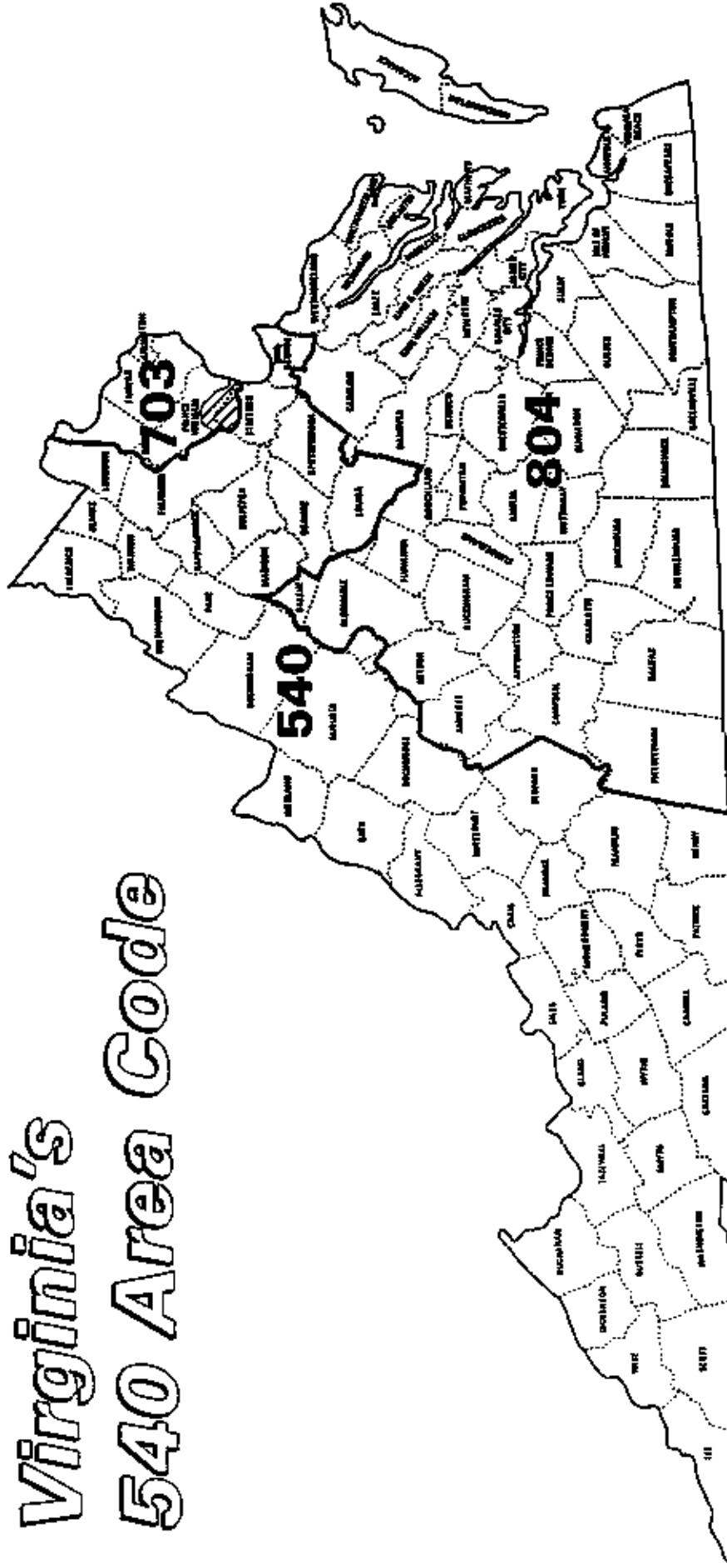
