**Abstract**

This IL provides industry notification of the impending split of the 203 NPA.

Letter Information (Includes safety liability disclaimer (if applicable), ordering information, originator's signature information)

We have been advised by Southern New England Telephone that substantial telephone number growth throughout the state of Connecticut necessitates splitting the existing 203 NPA and the simultaneous introduction of a new 860 NPA.

The Fairfield and New Haven counties in the southern part of the state will retain the 203 NPA; and Hartford, Litchfield, Middlesex, New London, Tolland, and Windham counties will change to the 860 NPA.

The split of the 203 NPA, and the beginning of a permissive dialing period, is scheduled for 12:01 AM Eastern Time, Monday, August 28, 1995. During the permissive dialing period, either 203 or 860 will be acceptable in a dialed number terminating in the new 860 NPA. The permissive dialing period will end at 12:01 AM Eastern Time on Friday, October 4, 1996. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept. Changes in the local exchange routing information will be incorporated into the LERG and the NPA NXX Activity Guide (NNAG), and will be available by April 1, 1995.

SNET will convert all pertinent records to 860 NPA during the weekend of August 25, 1995. This includes customer service records and associated NPA information in other systems. After August 25, 1995, all inquiries must refer to the correct NPA code.

The attached map illustrates the 203 and 860 NPA configuration after the split. A listing of the communities to be served by each area code after the split is also attached.

A test number for the new 860 NPA will be established on or about July 22, 1995 with details to be provided later.

The following dialing procedures will exist for all NPAs in Connecticut:

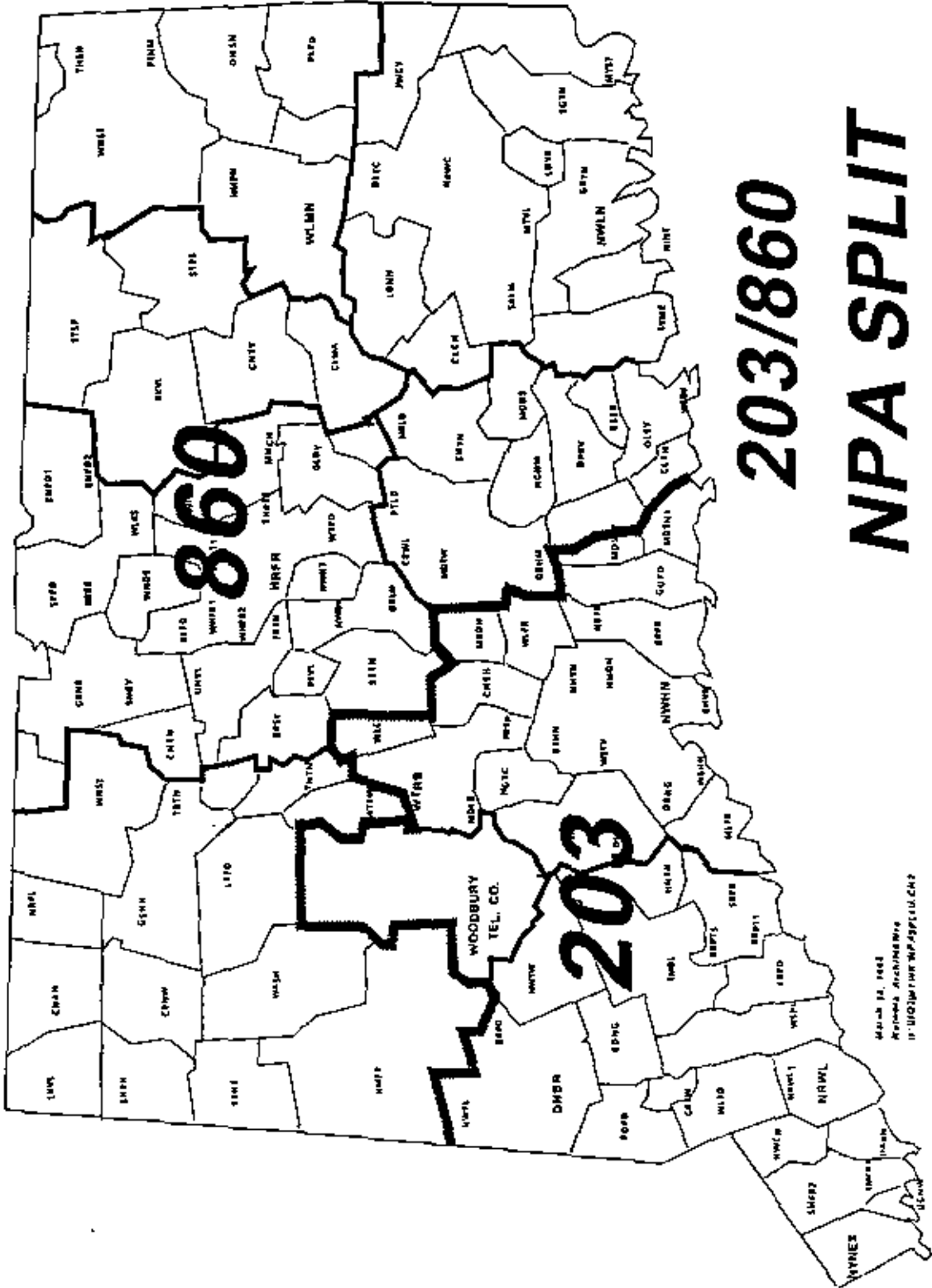
- All Home NPA (HNPA) "local" calls will be dialed on a seven digit basis with no prefix; i.e., NXX + XXXX (seven digits).
- All local calls across the 203/860 NPA boundary will be dialed on a seven digit basis with no prefix; i.e., NXX + XXXX (seven digits).
- All HNPA direct dialed "toll" calls (generally calls that incur an additional charge) will be dialed with a prefix "1" and then ten digits; i.e., 1 + HNPA + NXX + XXXX (1 + ten digits). Dialing of 1+ seven digits on toll calls within the HNPA is not permitted.
- All foreign NPA (FNPA) direct dialed toll calls will be dialed with a prefix "1" and ten digits; i.e., 1 + FNPA + NXX + XXXX (1 + ten digits).
- All operator assisted calls (both HNPA and FNPA) including credit card, collect, and third party calls will be dialed with a "0" prefix and ten digits; i.e., 0 + NPA + NXX + XXXX.
