Abstract

This IL provides industry notification of the impending split of the 904 NPA

We have been advised by BellSouth Telecommunications that substantial telephone number growth in north Florida necessitates splitting the existing 904 NPA and the simultaneous introduction of a new 352 NPA.

The new 352 NPA will be assigned to the Gainesville LATA. The remaining part of the current 904 NPA, including the Pensacola, Panama City, Tallahassee, Daytona Beach and Jacksonville LATAs, will retain the existing 904 area code.

The split of the 904 NPA, and the beginning of a permissive dialing period, is scheduled for 12:01 AM EST on Sunday, December 3, 1995. The permissive dialing period will end at 12:01 EDT on Monday, May 20, 1996. During the permissive dialing period, either the 904 or 352 NPA will be acceptable in a dialed number terminating in the new 352 NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept. Changes in the local exchange routing information will be incorporated into the LERG and the NPA NXX Activity Guide (NNAG) and will be available by September 30, 1995.

BellSouth will convert all pertinent records to NPA 352 the weekend of December 1, 1995. This includes customer service records and associated NPA information in other systems. After December 3, 1995, all inquiries must refer to the correct NPA code. The attached map illustrates the 904 and 352 configuration after the split. Also attached is a listing of the communities to be served in each area code after the split. The listing of the communities moving to the new 352 NPA also includes the associated central office codes (NXXs).

All international and domestic carriers are asked to ensure that the new 352 NPA has been activated throughout their networks prior to December 3, 1995. Test calls to verify routing to the new 352 NPA code may be made by dialing 1+352-848-0517. The test number will be in effect starting September 29, 1995. A recorded announcement will indicate that the test call has been successfully completed.

The following dialing procedures for the 904 and 352 NPAs will continue as follows:

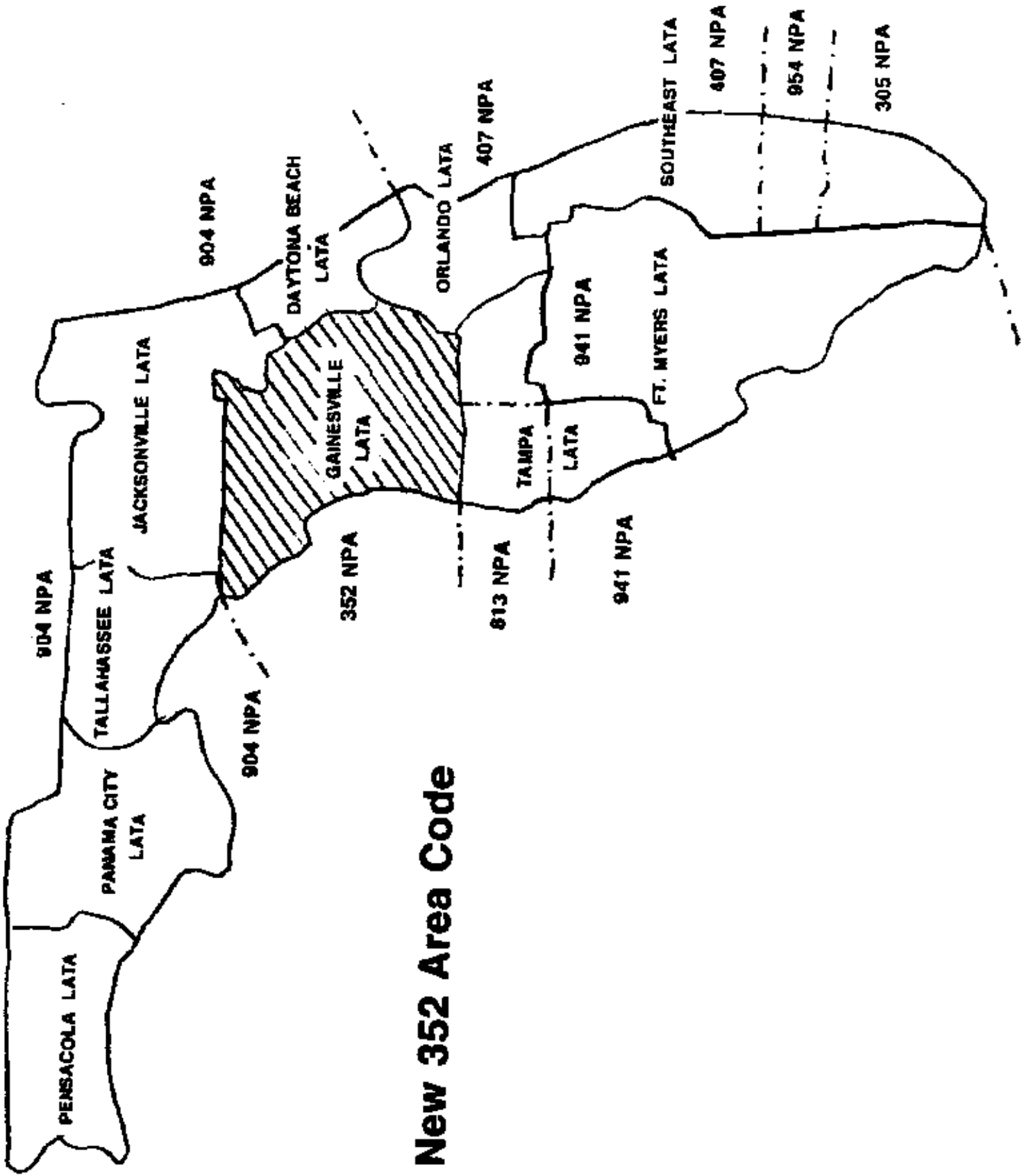
- All home NPA (HNPA) "local" calls will be dialed on a seven digit basis with no prefix; i.e., NXX + XXXX (seven digits).
- All HNPA direct dialed "toll" calls (generally calls that incur an additional charge) will be dialed with a prefix "1" and ten digits; i.e., 1 + HNPA + NXX + XXXX (1 + ten digits).
- All foreign NPA (FNPA) local calls will be dialed on a seven digit basis with no prefix, i.e., NXX + XXXX (seven digits).
- All FNPA direct dialed toll calls will be dialed with a prefix "1" and ten digits; i.e., 1 + FNPA + NXX + XXXX (1 + ten digits).
- All operator assisted calls (both HNPA and FNPA) including credit card, collect, and third party calls will be dialed with a "0" and ten digits; i.e., 0 + NPA + NXX + XXXX.
