**Abstract:**

**This IL provides industry notification of the impending split of the 407 NPA.**

**Letter Information (includes safety liability disclaimer (if applicable), ordering information, originator's signature information)**

We have been advised by BellSouth Telecommunications that substantial telephone number growth in central and southeast Florida necessitates splitting the existing 407 NPA and the simultaneous introduction of a new 561 NPA.

The existing 407 NPA will be split at the Orlando/Southeast Florida Local Access and Transport Area (LATA) boundary with the Orlando LATA retaining the 407 area code. The Southeast Florida LATA portion of the existing 407 NPA, including the area from Sebastian to Boca Raton, will change to the new 561 NPA.

The split of the 407 NPA, and the beginning of a permissive dialing period, will take place at 2:00 AM EDT, on Monday, May 13, 1996. The permissive dialing period will end at 2:00 AM EDT on Sunday, April 13, 1997. During the permissive dialing period, either 407 or 561 will be acceptable in a dialed number terminating in the new 561 NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept.

BellSouth will convert all pertinent records to NPA 561 the weekend of May 10-12, 1996. This includes customer service records and associated NPA information in other systems. After May 13, 1996, all inquiries must refer to the correct NPA code.

The attached map illustrates the 407 and 561 NPA configuration after the split. Also attached is a listing of the communities and central office codes (NXXs) to be served by each area code after the split. Revisions to the NXX listing may be found either in the LERG or the NPA/NXX Activity Guide (NNAG). Current information concerning NXXs is available by license contract from the Bellcore Traffic Routing Administration (TRA) organization, which can be contacted by dialing the TRA Hotline at (908) 699-6700.

All international and domestic carriers are asked to ensure that the new 561 NPA has been activated throughout their networks prior to May 13, 1996. Test calls to verify routing to the new 561 NPA can be made by dialing 1+561-615-8484. The number will be in effect starting March 1, 1996. A recorded announcement will indicate that the test call has been successfully completed. Calls to report troubles in reaching the test number should be directed to 1+800-691-2992. The test number will be disconnected on May 18, 1997.

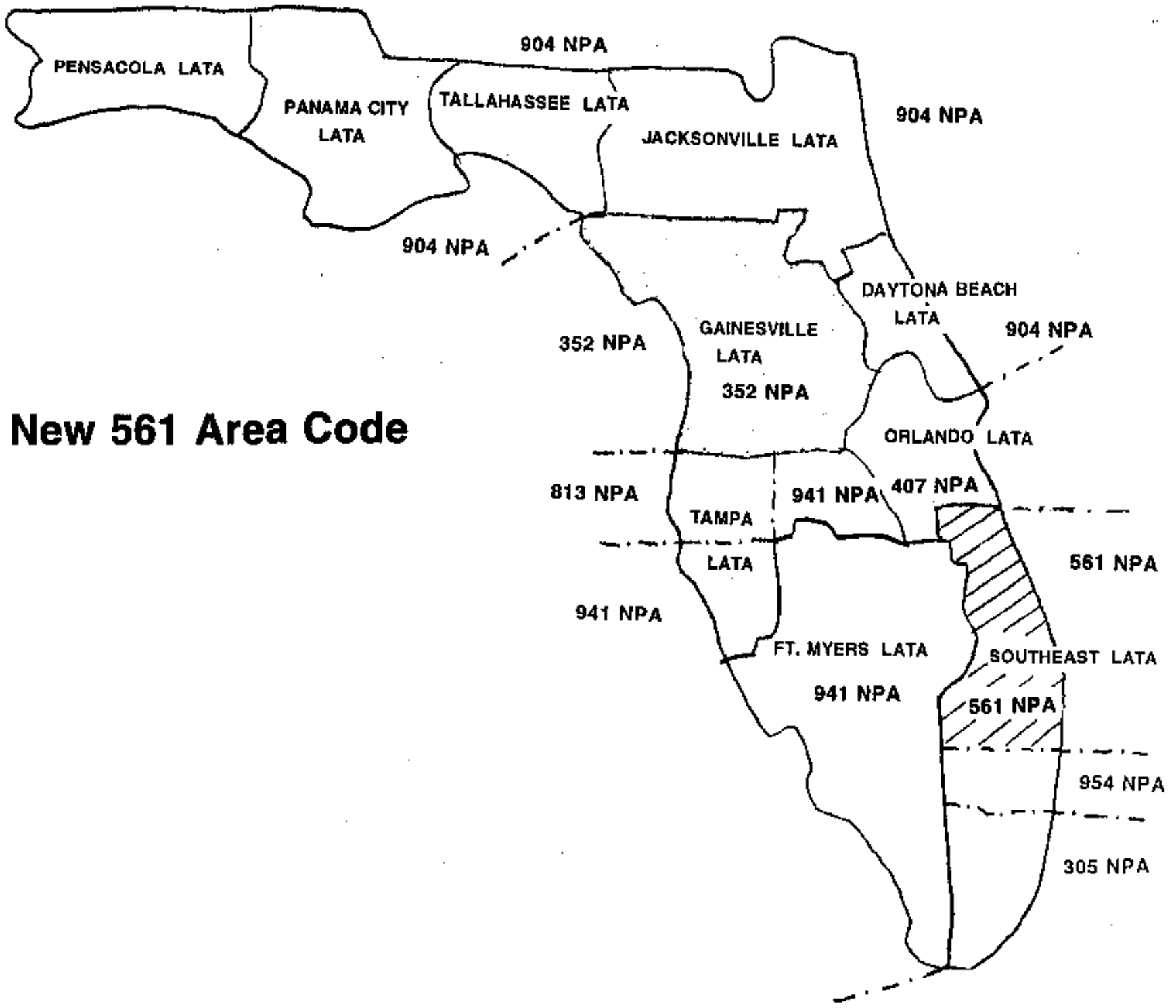
The following dialing procedures will continue for the 407 and 561 NPAs:

- All home NPA (HNPA) "local" calls will be dialed on a 7-digit basis with no prefix; i.e., NXX + XXXX (7 digits).
- All HNPA direct dialed "toll" calls (generally calls that incur an extra charge) will be dialed with a prefix "1" and 10 digits; i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).
- All foreign NPA (FNPA) direct dialed "toll" calls will be dialed with a prefix "1" and 10 digits; i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- Operator assisted calls (both HNPA and FNPA) including credit card, collect, and third party calls will be dialed with a "0" prefix and 10 digits; i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).
