Subject: NPA 513 Boundary Realignment – Franklin Rate Center (Ohio)

On September 28, 2000, the Public Utilities Commission of Ohio (Commission) in Case No. 99-668-TP-COI, approved a single all-services distributed overlay as the relief method for the 513 NPA that serves southwestern Ohio. Details of the overlay can be found in Planning Letter 264.

The Order also directed the realignment of the Franklin rate center from the 513 NPA to the 937 NPA. This realignment will impact only the following five NXXs, presently assigned in the Franklin rate center: 704, 743, 746, 748 and 790.

On April 12, 2001, the Commission amended its original order to modify the permissive and mandatory dialing dates of this realignment. Permissive dialing will commence at 12:01 a.m. local time on May 19, 2001 and will continue until November 17, 2001. During the permissive dialing period, calls originating outside the 513 and 937 NPAs and terminating in the Franklin rate center may be made by dialing either the 513 or the 937 NPA. Callers within the Franklin rate center making local calls may dial 7-digits for calls terminating within the 513 NPA, including the Franklin rate center, but must dial 10 digits for calls terminating within the 937 NPA. 7-digit dialing for local calls originating the Franklin rate center and terminating in the 937 NPA is not possible during the permissive dialing period due to conflicts in local calling scopes.

On November 17, 2001, the permissive dialing period comes to an end, and the 5 NXXs in the Franklin rate center will move to NPA 937. As of that date, the dialing plan for calls originating in the Franklin rate center will be as follows:

- All local calls terminating in NPA 937 will be dialed as 7 digits (NXX+XXXX).
- All local calls terminating in NPA 513 will be dialed as 10 digits (NPA+NXX+XXXX).
- All toll calls will require the prefix "1" and ten digits (1+NPA+NXX+XXXX).
- All operator-assisted calls, including credit card, collect, and third party calls, will require the prefix "0" and 10 digits (0+NPA+NXX+XXXX)

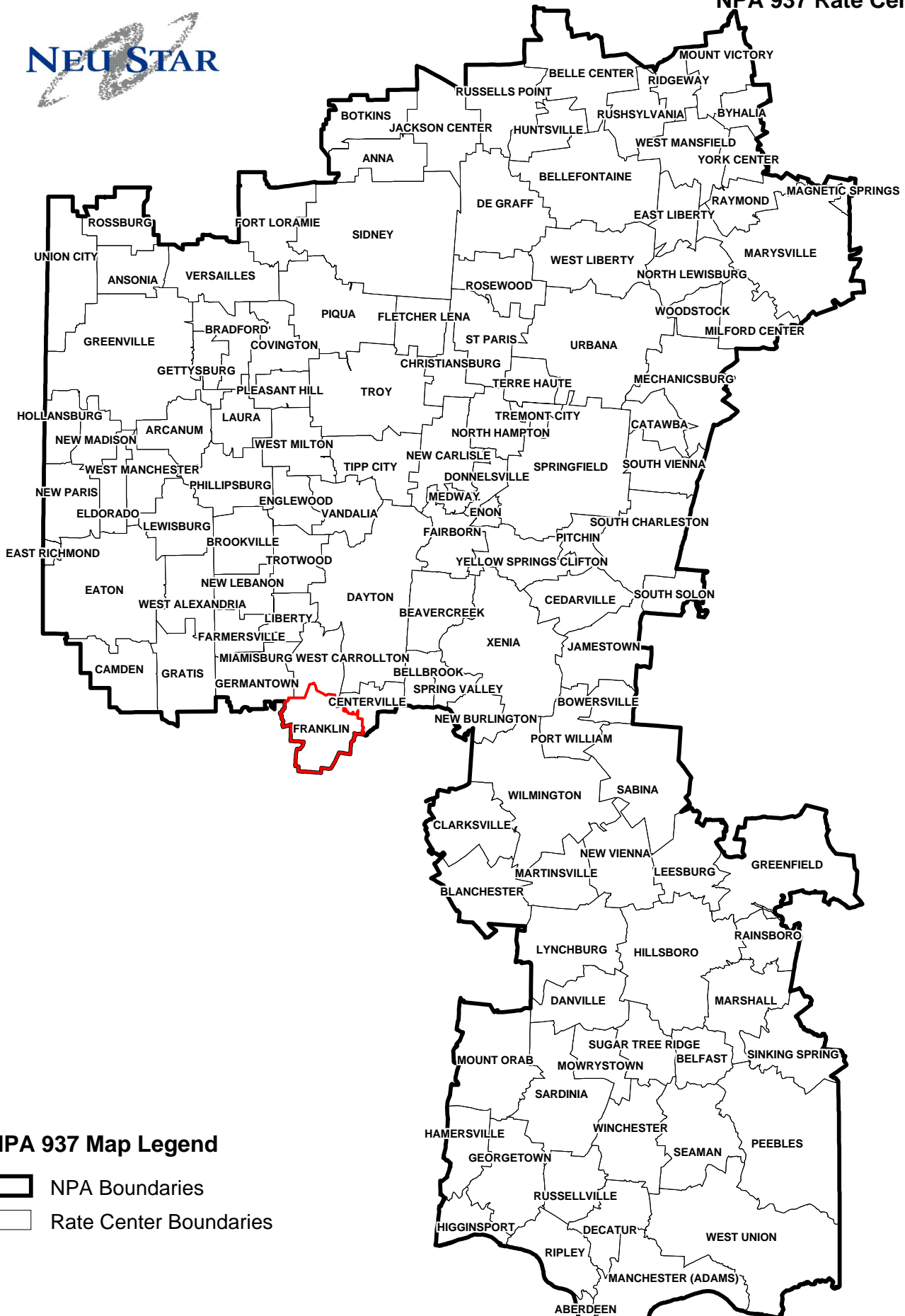
All international and domestic carriers should ensure that this realignment has been identified and activated throughout their networks by May 19, 2001.

Service providers receiving NXX assignments in the Franklin rate center with effective dates prior to November 17, 2001 are reminded that LERG records must be established for the NXX in both the 513 and 937 NPAs, with a disconnect date of November 17, 2001 for the 513 NXX reflected in their LERG records.



