Subject: 504/985 Split – Extended Permissive Dialing for Wireless (Louisiana)

On October 20, 2000, NANPA issued a planning letter (PL-242) to announce the split of the 504 NPA in Louisiana. Attached to that planning letter was a list of the NXX codes affected by the split, which included certain wireless NXX codes that were granted an extended permissive dialing period until 12:01 AM on October 21, 2002, in accordance with industry consensus. Since that time a number of additional wireless NXX codes were granted an extended permissive dialing period at the request of the Louisiana Public Service Commission. Attached, for your information, is a revised list of all wireless NXX codes in the 504 NPA that are currently affected by the extended permissive period.
