Subject: NANP-Split of 317 (Indiana) Numbering Plan Area (NPA)

We have been advised by Ameritech that substantial number growth in the central portion of Indiana, including Indianapolis, necessitates splitting the existing 317 NPA and the simultaneous introduction of a new NPA 765. The following is a description of this relief plan.

The Indianapolis metro area will retain the 317 NPA while the exchanges outside the metro area will receive the new 765 NPA code.

The split of the 317 NPA and the beginning of a permissive dialing period are scheduled for 12:01 AM EST on Saturday, February 1, 1997. The permissive period will end at 12:01 AM EST on Saturday, June 28, 1997. During the permissive period, either 317 or 765 will be acceptable in a dialed number terminating in the new 765 NPA. After the permissive period, calls dialed with an incorrect NPA code, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept.

The attached map illustrates the 317 and 765 configuration after the split, showing approximately where the boundary between the NPAs will be located. Also attached are listings of all assigned NXXs within the 317 and 765 NPAs as of 8/6/96. For each NPA, one listing shows the NXXs sorted in numerical order, and another listing shows the NXXs by community sorted in alphabetical order. Revisions to the NXX listings may be found either in the Local Exchange Routing Guide (LERG) or the NPA NXX Activity Guide (NNAG). Current information concerning NXXs in these publications is available by license contract from Bellcore's Traffic Routing Administration (TRA) group, which can be contacted by dialing the TRA Hotline at 908-699-6700.

All international and domestic carriers should ensure that the new 765 NPA has been activated throughout their networks prior to February 1, 1997. The test number to the new area code, 765-281-6988, will be activated on January 4, 1997 and will remain operational until June 28, 1997. Calls successfully completed to the test number will receive a recorded announcement.

The dialing procedures for the 317 and 765 NPAs will be as follows:

- All home NPA (HNPA) local calls will be dialed on a 7-digit basis with no prefix, i.e., NXX + XXXX (7 digits).
- All local calls between the 317 and 765 NPAs, will be dialed on a 10-digit basis without a prefix, i.e., NPA + NXX + XXXX (10 digits).
- All HNPA and foreign NPA (FNPA) toll calls, i.e., calls that generally incur an extra charge, will be dialed with a prefix "1" and 10 digits, i.e., 1 + NPA + NXX + XXXX (1 + 10 digits).

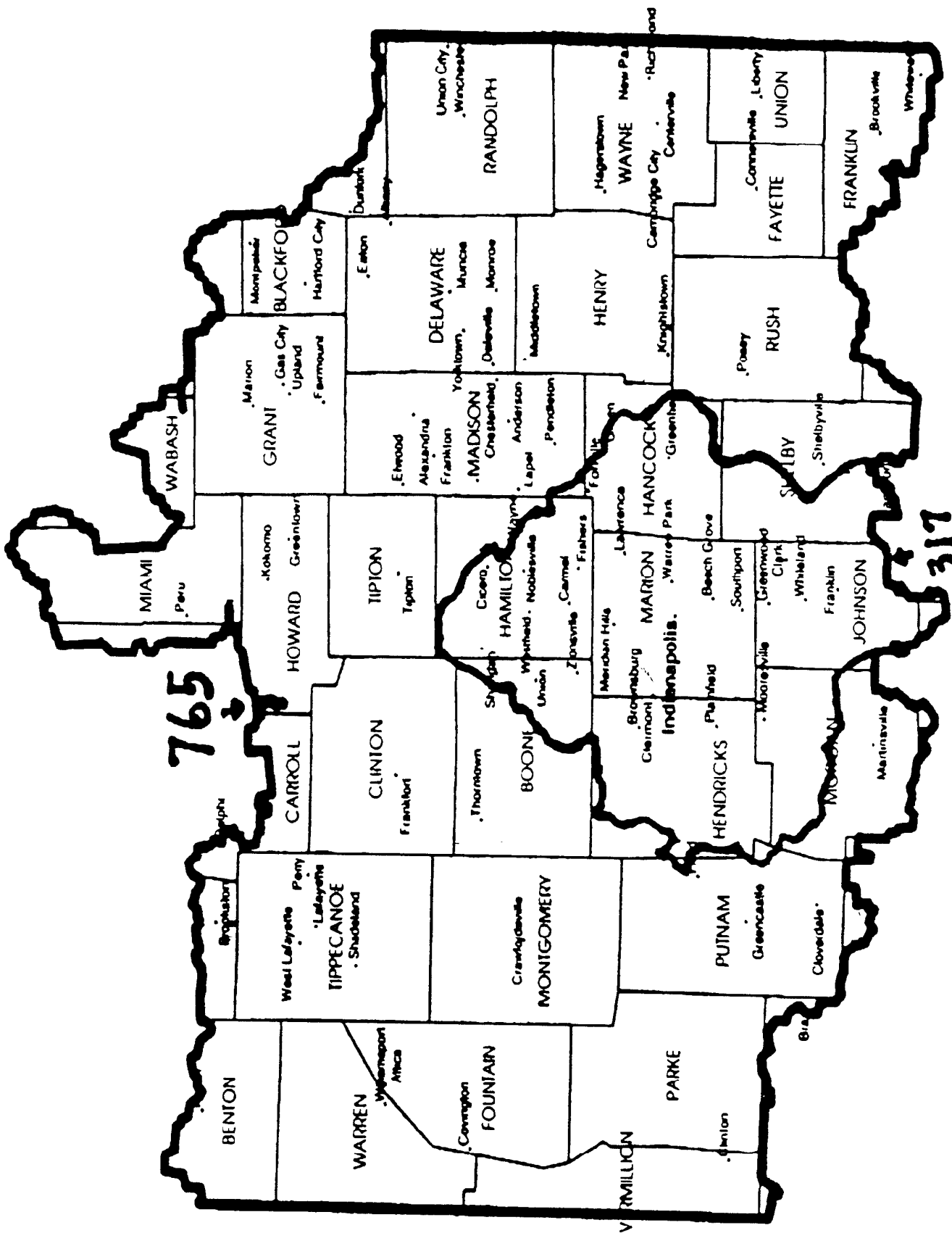
- All operator assisted calls, including credit card, collect, and third party calls, will be dialed with a "0" prefix and 10 digits, i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).
