In Telecom Decision CRTC 2021-372, dated 10 November 2021, the Commission approved the 343/613 Relief Planning Committee's report which recommended relief for area codes 343/613 in the eastern part of Ontario be provided through a distributed overlay of new area code 753 starting 26 March 2022.

New area code 753 has been assigned by the North American Numbering Plan Administrator (NANPA) and will be implemented as a distributed overlay over the geographic area in the eastern part of Ontario currently served by the 343 and 613 area codes. The area served by NPA Codes 343/613 and the new 753 NPA Code consists of 132 Exchange Areas, including the Exchange Areas of Ottawa, Kingston, Belleville, Brockville and Cornwall. A map showing the location of the area served by NPAs 343 and 613, and a list of the 132 Exchange Areas are attached to this letter.

When the new 753 NPA is introduced, the dialling plan for the 343/613/753 overlay area will be as follows:

- All local calls, including Extended Area Service calls, originating within the 343/613/753 overlay area must be dialled with 10-digits; i.e., NPA-NXX-XXXX.
- Toll and alternately billed service calls originating within the 343/613/753 overlay area will continue to be dialled with 10-digits after the appropriate prefix digit(s).

All international and domestic Telecommunications Service Providers (TSPs) should activate the new 753 NPA throughout their networks by the start date for network testing (26 October 2021).

The following test numbers for the new NPA 753 will be made available effective **26 January 2022**. Routing of calls to NPA 753 can be verified by dialling the 8378 (TEST) numbers which do not provide answer supervision. Billing of calls to NPA 753 can be verified by dialling the 2455 (BILL) numbers which provide answer supervision.

The disconnection dates for the test numbers will be between 26 April 2022 and 1 June 2022.

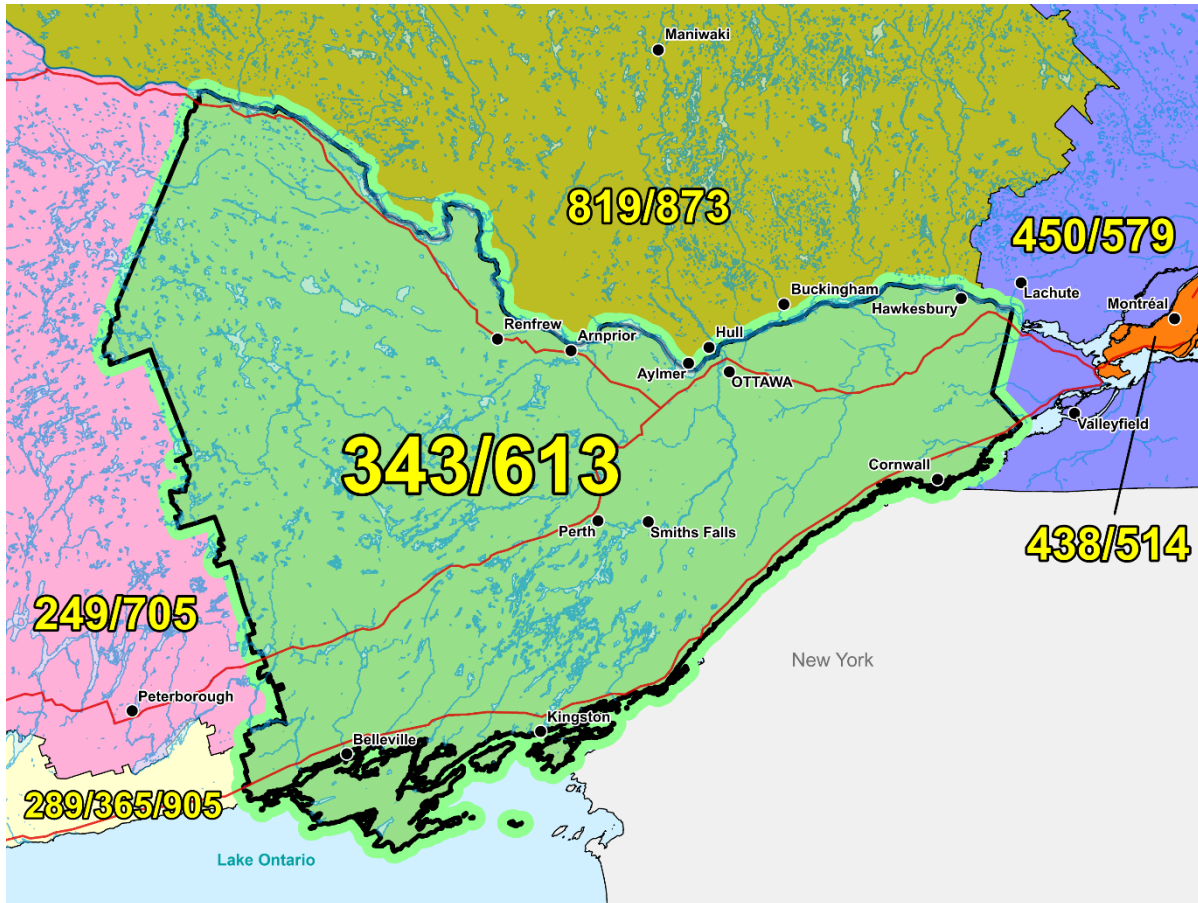
